

THE DACHSHUND CLUB OF AMERICA, INC.

MEMBERSHIP GUIDELINES

The objects of the Dachshund Club of America are to encourage and promote quality in the purebred breeding of the Dachshund and to do all possible to bring their natural qualities to perfection; to encourage the organization of independent local Dachshund Specialty Clubs in those localities where there are sufficient fanciers of the breed to meet the requirements of the American Kennel Club; to urge members and breeders to accept the standard of the breed as defined by the Dachshund Club of America and approved by the American Kennel Club as the only standard of excellence by which Dachshunds shall be judged; to do all in its power to protect and advance the interests of the breed and to encourage sportsmanlike competition at dog shows, field trials, obedience trials, and earth dog tests; to conduct sanctioned matches and specialty shows, field trials, obedience trials, and earth dog tests under the rules of the American Kennel Club.

Membership is open to serious fanciers who have demonstrated a significant on-going interest in the Dachshund, who are in good standing with the American Kennel Club, subscribe to the objects of the Dachshund Club of America, and agree to abide by the Bylaws of the Dachshund Club of America, its Code of Ethics, and the rules of the American Kennel Club.

APPLICATION INFORMATION

1. Applicants should document direct involvement in AKC events with the Dachshund breed and or purebred dogs.
2. Applications should have attached the written Sponsors Questionnaire of two active members in good standing who know the applicant.
3. Applicants who buy dogs for, or sell dogs to commercial outlets will not be considered for Membership.
4. It is the responsibility of the applicant to forward the properly completed Application for Membership and Sponsorship Questionnaire to the membership Administrator of the Dachshund Club of America. Please do not write on the back of any form; attach additional pages when necessary.
5. The name and address of each applicant will be published in the first available DCA newsletter prior to Board review.

SPONSORSHIP GUIDELINES

1. Sponsors shall be active members of the Dachshund Club of America in good standing, and who know the applicant.
2. Both sponsors may not be from the same household or family, and should be from the applicant's geographic area.
3. By sponsoring membership applications, Dachshund Club of America members attest to their personal knowledge of the applicant, including his or her interests in the breed, sportsmanship, and ethical conduct.

APPLICATION PROCEDURE

1. All applicants are acknowledged by the Membership Administrator.
2. The correct membership fee must accompany each application. If an application for membership is returned, the money shall be refunded.
3. Only eligible and properly sponsored applicants for whom applications have been received by the Membership Administrator will be considered for Membership.
4. The applicant's name(s) including the names of each applicant's sponsors will be published in the next available DCA Newsletter and a deadline will be published for the submission of written communications to the Board on the qualifications and ethical conduct of individual applicants.
5. Written comments regarding applicants will be considered confidential communications the Board. However, members will be informed that copies of written comments on an individual applicant will be made available to that applicant immediately on written request by the applicant.
6. The withdrawal of endorsement by a sponsor prior to the vote of the Board on an applicant's admission to membership renders the application void, and the applicant must reapply.
7. An application which did not received an affirmative vote by two-thirds of the Board of Directors may be presented by the applicant's endorser (sponsor) at the next annual meeting of the Club and such applicant may be elected by favorable vote of seventy-five percent (75%) of the members present.

Dachshund Club of America Code of Ethics

1. To devote myself to the betterment of the breed.
2. To keep my dogs in healthy condition and in a healthy environment.
3. To ensure that my dogs are not a nuisance to my neighbors or my community.
4. To cover by written agreement, all stud service terms and keep accurate written records of matings, births, registration and so forth.
5. To accept full responsibility for every dog that I breed. To sell on a contract that ensures that I am contracted whenever the owner cannot keep a dog at any time in the dog's life. To assist in the placement of the dog or accept its return. As owner of a stud dog, to offer stud services only to those breeders who accept full responsibility for what they breed.
6. To under no circumstances, surrender a dog or puppy to a humane society or shelter. If the animal is unplaceable because it has destructive temperament, is seriously injured, terminally ill or it would be inhumane to prolong life, to take responsibility for the euthanization of the dog.
7. To refrain from any deceptive or erroneous advertising.
8. To cover, in writing, all Bills of Sale with detailed accuracy including: a) Registration/litter papers, b) A three generation pedigree, c) A complete medical history (record), d) Conditions and terms of sale, e) Details on proper feeding and care.
9. To consider issuing limited registration papers, subject to the rules of the AKC, or withholding registration papers until proof of spaying or neutering is presented on any dog sold or placed as a companion.
10. To never supply a Dachshund to pet shops, commercial brokers or dealers, raffles or similar projects.
11. To abide by and uphold the principles of the bylaws of the Dachshund Club of America, Inc. and the American Kennel Club, Inc.
