DCA FIELD TRIAL MERIT AWARDS: DCA Membership requirements for Awards will be in accordance with current policy as determined by the DCA Board for DCA Merit Award Programs. Only those points earned for placements in the Field Champion stakes at AKC licensed or member trials will count toward the DCA Field Trial Merit Awards. Points are tabulated using the Delaney System +1 for first through fourth place, based on the number of starters. In the case of ties, dogs will receive the same place award, with the next place(s) being skipped. A minimum of two placements in Field Champion stakes during the award year are required to earn an award, and / or be included in preliminary listings.

Regarding Field Trial Results

— A ramble from Voice editor Tracy Freeling

Several years ago, DCA webmaster Andra O'Connell developed an online reporting form for field trial and specialty results. This system is accessed through the DCA website and facilitates the posting of event information without a major time investment for Andra – who like the rest of us is a *volunteer*. Equally important, however, each event report generated via Andra's system is automatically relayed to the DCA Newsletter and Voice editors as well as the DCA Trophy Chair. –That would be Lynne Dahlen, Tracy Freeling and Sheila Parish respectively.

Why?

Those clubs that participate in the DCA trophy plan are required to supply the results from their trials to DCA. Sheila Parish needs the total trial entry count as well as the variety, owner's name, address and telephone number of the absolute winner in order to mail out the appropriate plaque (or medallion) earned. Provided results have been entered in both a timely and complete fashion, each absolute winner should receive their award within two weeks.

The DCA Newsletter and Voice publications help keep the Dachshund community around the country informed about events. In addition, they record our breed's history. Copies of each Newsletter and Voice are placed in the DCA Archives so that future generations will be able to research the accomplishments of today's competitors. DCA Awards Chair Ann Wlodkowski also receives a printed copy of each issue of the Voice and uses it to confirm the qualitative requirements of the Register of Merit program.

If results are not reported to DCA, they will not be included on the website or in the Newsletter ... end stop.

All licensed and member Dachshund field trials ARE reported in the Voice. If the information published in the Voice for a specific event is incomplete, however, that occurred because the trial-giving club did not provide the data to me. In some cases, the club provided NO information, but I obtained the placements via the Event Search function on AKC's website. As most field trial enthusiasts are aware, the AKC system does not include NBQ information. Nor does it report the results from the inter-stake competitions that culminate in the Absolute since those are not AKC activities but instead exist courtesy of the DCA standing rules. I do what I can to collect the pertinent information for each and every Dachshund field trial, but in the end it all comes down to having a willing partner at the club level.

I appreciate the many trial chairs and secretaries who diligently report results ... as do Andra, Lynne and Sheila. You make our jobs easier.

Field trialers ...

If you won a plaque and do not receive it during the two week time frame mentioned above, your first call should be to the trial secretary not Sheila.

If your dog's placements are not mentioned in DCA publications or on the website, encourage the local clubs to send in their results.

If you are responsible for reporting your club's results, please DO!

If you experience difficulties with the online form, send a polite email to Andra describing the situation so she can diagnosis the problem.

If you have additional trial information or photos, PLEASE let me and / or Lynne Dahlen know. I cannot promise you that *everything* you might send in will get used, but there are many items that we both would love to know about and share with our readers.

AKC Recording Fee Increase for Earthdog Tests

At its November meeting, the AKC Board of Directors discussed a staff proposal to raise the **recording fee** for Herding, **Earthdog**, and Lure Coursing from **\$3.00** to **\$3.50**.

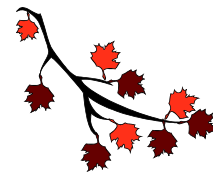
A motion was made and approved unanimously to waive the usual prior notice requirement thereby allowing the board to vote on the proposal at the November meeting. The board voted unanimously to adopt the proposal which will impact all events held on or after March 1, 2011.

Performance Event Application Fee Refunds

Also at its November meeting, the AKC Board of Directors discussed a staff proposal to discontinue the practice of refunding a club its AKC event application fee if a performance event was cancelled.

A motion was made and approved unanimously to waive the usual prior notice requirement thereby allowing the board to vote on the proposal at the November meeting. The board voted unanimously to adopt the proposal. No effective date was listed so this change is probably effective immediately.
